We are pleased to offer for sale this orchard property and irrigated farm located in the Naches Heights area of Washington State. This orchard consists of 118.2 acres of planted orchard. Varieties consist of Red Delicious, Golden Delicious, Cosmic Crisp, Gala, Fuji, Honeycrisp apples and Bartlett/D'Anjou pears.

LOCATION

The subject property is located in the Tieton area, just to the east of the community of Tieton. The subject property is accessed from Yakima via Highway 12 to Naches, heading northwest; then south at the light in Naches onto Naches-Tieton Rd; stay on it heading south up the hill and then turn left onto Naches Heights Rd and drive for about 1 mile until reaching one of the subject tracts (Bethel Ridge) at the approximate physical address of 8570 Naches Heights Rd. There are multiple routes that could be utilized, but this would be one of the more well-travelled routes and easiest routes from downtown Yakima.

Irrigation

Irrigation water for the subject property farm is provided by the Yakima-Tieton Irrigation District. Each share delivers 4.9 gallons per minute and 1.2 shares is enough water for 1 acre of irrigable land. The YTID is a senior district meaning that in "short" water years, the users in this district usually still get their full allocation of water. This is ample water for the current planted orchard.

Well Water: There are domestic wells for the single-family residences and worker housing. No verification of water supply/condition was made and the current wells are assumed adequate. The domestic wells are all community wells and necessary well agreements will/may need to be modified upon purchase.

Frost Protection

The property has 7 wind machines. Frost protection is managed by using a combination of wind machines and under-tree water.
