## Instructions on how to embed the NON-branded link into the MLS public remarks section:

- Go to Edit listing details
- Put all other remarks **first** and include *link last* (not doing so will make the entire rest of the remarks a link)
- copy the **NON-branded** link of your virtual video or 3-D tour from the site (**using a branded link will result in a fine from the MLS**)
- in front of the link type `<a href="(paste the NON-branded link)">` and after add a label for the link that makes it obvious it's the virtual 3-D or video (**see image below**)

**Please note that it is not a double quotation mark around the web address above; it is actually two single (') marks on each end of the URL.**
